SUMMARY:

This agenda item provides discussion/deliberation on the Preliminary Budget for 2021-2022 and the proposed property tax levy for 2021 (if needed). All of the procedural requirements for Council action have been completed.

In order to collect property tax during 2021, the approved levy must be submitted to the Snohomish County Assessor by November 30, 2021. The legal deadline to adopt the 2021-2022 Budget is December 31, 2020, but the adopted budget calendar indicates that Council action will occur on November 23, 2020.

POLICY QUESTION(S) FOR COUNCIL CONSIDERATION:

- 1. Is the proposed, flat property tax levy of \$4,300,000 consistent with City Council priorities?
- 2. What, if any, adjustments to the Preliminary Budget are needed to ensure alignment with the Community Vision and the Strategic Plan, 2018-2022?

ACTION:

Discuss any remaining issues/questions.

BACKGROUND:

The Preliminary Budget and the proposed property tax levy have been developed over many months and have been discussed/reviewed during many Council meetings. The City Council conducted public hearings on November 9, 2020, and discussed budget issues on November 16, 2020.

In recognition of the economic hardships created by COVID-19, it is proposed that the property tax levy for 2021 remain the same as 2020: \$4,300,000. For the median-priced homes, this will result in small decrease in the City's portion of property tax (~\$1.50/year). There appears to be no opposition to this proposed levy amount.

Budgets are financial expressions of community values and priorities. COVID-19 impacts upon City revenues have been and will be considerable. This Preliminary Budget for 2021-2022 is nearly \$7 million less than the adopted budget for 2019-2020. Despite the reduction in funds available, departments will continue to pursue the priorities of the Strategic Plan, 2018-2022.

Re: Lynnwood Consideration of Retail Cannabis

Council Member Hurst,

My name is Josh Estes and I am a Lobbyist and Managing Partner with Pacific Northwest Regional Strategies, LLC. Along with my business partner Sean L. O Sullivan, our firm represents the legislative and community affairs interests of a number of clients in the Pacific Northwest and Snohomish County. Included in our portfolio are a number of local cannabis retail store owners.

I am reaching out to you today on behalf of these clients to check-in on the possibility of providing information or support with respect to the council's consideration and exploration of reversing the outright ban on cannabis retailers in the city that was brought forth during the September 14th, 2020 council worksession and referenced in an article that was recently published by the Everett Herald. The article mentioned your interest and introduction of the topic. We had previously spoken with you back in September about our willingness to participate in the discussion and hopefully answer some of the common questions that might arise.

As local operators with owners who reside in Snohomish County, our clients are committed to supporting local jurisdictional efforts to re-examine earlier ordinances that were established largely in part to the industry being in its infancy and not really having an understanding of some of the potential impacts to public safety and the economy.

Luckily, several years have passed since the legalization and consolidation of the medical/recreational markets. During that time, the cannabis industry has provided for considerable revenues both to the state and to the local economy. We have also seen positive benefits to local communities through partnerships with local non-profits like Leadership Snohomish County, Childstrive, Housing Hope, Mari's Place, Seattle Children's Hospital and area food banks.

One of the more common concerns by jurisdictions revisiting their codes, has been wanting to have a clear understanding of the impacts of this industry on crime and public safety. We have been directly involved with the recent decision by the City of Everett, to lift their ban on additional retail cannabis stores which was passed by the Everett Council with a vote of six to one (6-1) last month in October. The decision to reverse the ban on more stores, was carefully considered and included extensive research by the council's public safety subcommittee on the potential public safety impacts, which by Everett Police Departments own Crime Analysis Unit, found no evidence of an increase in calls for service for licensed cannabis retailers than other similar retail or business establishments.

The City Council's willingness to reengage in the conversation to consider allowing retailers into Lynnwood is a discussion that we will be following very closely, and would like to offer our perspective and experience on, if the council is interested. We have provided similar information to a number of other City Councils regarding the benefits and common concerns that this industry can bring to your community and we would be happy to do the same in Lynnwood.

Additionally, we are only a few weeks away from a grand opening and ribbon cutting at one of our client's newest locations in the Harbour Pointe Area of Mukilteo and would love to welcome you or any of your colleagues on the council for a tour of this fantastic new space. This location is a great example of the different ways that adding these shops to your community can help to drive economic growth.

The Mukilteo store is uniquely situated in the same complex as other retail stores, a Les Schwab Tire Center and is comingled with a well-established full-service carwash. We have found that experiencing a store first-hand often helps to answer many of the common questions for those new to the industry and can help you visualize the endless possibilities for future economic growth that these stores bring.

We look forward to the possibility of working with the council to answer any questions that you might have, and to address the concerns of the community while providing an opportunity for new revenue and economic growth.

The combined (single day) effort by Kushman's and The Kushery, resulted in a total donation to Seattle Children's of three-thousand and seven hundred dollars to fight childhood cancer. <u>Preliminary Research Summary- Marijuana Retail Stores</u> <u>11/18/20</u>

Where we are now- City of Lynnwood

Initiative 502 was passed by the state of Washington in 2012.

In 2014 a public hearing was held, and a temporary ordinance was adopted to prohibit marijuana sales and production within the city of Lynnwood for 6 months.

- 4 more 6-month extensions took place in 2014 and 2015
- During these discussions, several marijuana lobbyists and business owners were given the opportunity to share information with the council.
 - o Several members of the public spoke out for the prohibition extension.

In June of 2015, Ordinance 3136 passed on June 15, 2015 prohibits 1) retail sales, production, and processing of marijuana and/or marijuana-infuse products and 2) medical marijuana collective gardens.

In 2019, Regulations for the City Center Zones was amended to prohibit these activities within the City Center (Ordinance 3336; May 13, 2019).

Tax Revenue***

One benefit cited for allowing marijuana operations is the tax revenue collected from retail sales. This revenue is collected by the state and then a portion is redistributed back to the cities and counties who do not prohibit these businesses.

- The amount distributed back to local governments is determined by the legislature. The current two-year budget calls for \$15,000,000 (3.9%) of the \$395,0000,000 collected from sales and licensing is distributed to local governments.
- The amount passed back to each city and county is calculated based on a combination of 1) population and 2) \$ retail sales. Then 50% is given to the city and 50% is given to the county.
- As an example, below are the annual distributions to neighboring communities with similar populations who do not prohibit these businesses:
 - Longview \$91,000
 Mt. Vernon \$65,000
 Edmonds \$71,000
 Issaquah \$77,000
- Note: Local governments <u>are not permitted</u> to impose an additional tax on_these businesses.


Another question was whether it was a risk given that federal banks would not support these operations.

• Doing business in cash is still an important issue for marijuana businesses, but there are several state-chartered banks and credit unions providing banking services. The percentage of retailers with bank accounts is very high.

Washington City Options*

Minimum Buffer Distance RCW 69.50.331(8) requires licensed marijuana producers, processors or retailers to be located at least 1,000 feet from the following entities:

• Elementary or secondary school; Playground; Recreation center or facility; Childcare center; Public park; Public transit center; Library; or any game arcade (where admission is not restricted to persons age 21 or older).


Local governments may reduce the 1,000 feet buffer to 100 feet around all entities except elementary and secondary schools, and public playgrounds by enacting an ordinance authorizing the distance reduction. See RCW 69.50.331(8)(b).

Options for regulations include:

- 1. **Reduce Buffer Zones** i.e. Shelton Municipal Code Sec. 20.72.020 Reduces buffers to 500 feet for researchers, processors, and producers (not retailers) for childcare centers, arcades, libraries, public parks, public transit centers, and rec. facilities. Keeps 1,000-foot buffer for other entities (schools, etc.).
- 2. **Allow Medical Marijuana Cooperatives** i.e. Tacoma Amended (2016) Provides that cooperatives must be operated in a manner that is clearly secondary to the primary use of the property as a residence so as to not affect the character of the neighborhood. Cooperatives shall not generate nuisances such as traffic, on street parking, noise, etc.
- 3. **Prohibit Medical Marijuana Cooperatives** i.e. Anacortes Ordinance (2016)— Amends municipal code prohibiting marijuana cooperatives in all city zones and replaces Ordinance No. 2985 (2016) which extended a moratorium on marijuana cooperatives. Allow Marijuana Businesses in Appropriate Zoning Districts Below are examples of ordinances that establish permanent zoning regulations for state-licensed marijuana
- 4. **Limit Number of Retail Marijuana Businesses** i.e. Everett Ordinance (2016) Limits the number of retail marijuana stores allowed in the city to a maximum of five.
- 5. **Adopt a Moratorium on Marijuana Businesses** i.e. Eatonville Ordinance (2018) Imposed a moratorium on the production, processing, or retail sale of recreational marijuana. Expired August 26, 2018.
- 6. **Prohibit Marijuana Businesses** i.e. Leavenworth Municipal Code— Provides that every business licensee must comply with all federal, state, and city statutes, laws, regulations, and ordinances relating to the business premises and the conduct of the business thereon.

Note: Local governments <u>cannot</u> regulate these businesses using a referendum.

Below is a snapshot of where each nearby city stands. Out of 281 cities, 84 (30%) prohibit marijuana sales and production. Residents interested in purchasing can go to Everett, Mukilteo, Edmonds, or Lake Forest. *



Staff are excited to announce the successful acquisition of a 4.45-acre parcel of undeveloped and forested land within the City of Lynnwood, at the intersection of 164th Street SW and 60th Ave W (see vicinity map below). The property borders city-owned open space to the north and west and is contiguous to the 90.25 acres of Lund's Gulch open space that the City of Lynnwood and the Brackett's Landing Foundation have acquired since 1996 with Snohomish County Conservation Futures funds.

Staff identified this corner parcel as a strategic acquisiton opportunity to increase the protected area for Lund's Gulch Creek and provide a key access point for future trail development to connect to the existing trails within Lund's Gulch Open Space.

The property, purchased more than forty years ago by the McCrary family, had been passed down to brothers, AR & Frank. AR's interest passed to his wife, Bonnie, after he passed. Both Bonnie and Frank were aging and wished to see the property remain preserved as open space and in 2018, they approached the City as willing sellers. Unfortunatly, Mr. McCrary passed earlier this year but his niece (who since received her mother's interest) remained committed to realizing the intent to preserve this important open space in Lynnwood.

The McCrary's generously offered to discount the selling price to \$100,000 and donate the remaining value (a \$139,300 property value reduction) as part of a match towards a Snohomish County Conservation Futures Program (SCCFP) grant application. The City obligated a \$20,000 cash match. The SCCFP funds land acquisition through an application, evaluation, and competitive selection process. The City made a successful application to the County's grant program in 2019 and executed an Interlocal Agreement in January of 2020.

Staff used the City's Real Estate roster to hire a buyer's agent to assist with due diligence and executing a purchase and sale agreement. The City officially closed on the property on November 13th [projected as of the date of this memo]. As a condition of the Interlocal Agreement, we will also execute a conservation easement with the County on this property.

Staff extend gratitude the McCrary family and Snohomish County for making this acquisition within reach and possible.
