Council Member Frizzell read the Proclamation for Domestic Violence Awareness Month. Staff from Lynnwood Police Department's Victim Services (Tiffany Krusey, Victim Services Coordinator and Chris McBride) and the YWCA (Mary Anne Dillon and Karla Danson) were there to receive the proclamation. - Approve payroll in the amount of \$1,161,134.33 dated 09/10/2021.
